**CORRIGENDUM**

In reference to the earlier notification regarding Vacancy Circular of One (01) post of **Deputy Director (Shipping Services)**, in Directorate of Shipping Services (Group 'A' Gazetted) in the Pay Matrix (Rs.67700 – 208700) Pay Level – 11 on deputation basis for Three (03) years published in the Employment News on 08-14 March, 2025 edition. The Eligibility Criteria of earlier vacancy circular is hereby revised as per Recruitment Rule:

**Eligibility Conditions:-**

**Composite Method (Deputation (ISTC) plus Promotion):-**

1) Officers not below the rank of Lieutenant in the Indian Navy having sea or command experience.

OR

2) Officers working under the Central/States Govts./U.Ts/Public Sector Undertaking/Statutory Bodies and Autonomous Organization.

(A) (i) holding analogous posts on regular in the parent cadre; or

(ii) with Five (5) years service in the grade rendered after appointment thereto on regular basis in the Pay Matrix (₹ 53100-167800) Pay Level - 09 revised or equivalent in parent cadre/department; or

(iii) with Six (6) years service in the grade rendered after appointment thereto on regular basis in the Pay Matrix (₹ 47600-151100) Pay Level - 08 revised or equivalent in parent cadre/department; or

(iv) with Seven (7) years service in the grade rendered after appointment thereto on regular basis in the Pay Matrix (₹ 44900-142400) Pay Level - 07 revised or equivalent in parent cadre/department; and

**(B)** Possessing the educational qualification and experience prescribed for direct recruitment under para-7.

**Para 7 – Essential:**

- (i) Degree of a recognized University.
- (ii) Five years Administrative experience, out of which, three years should be in operation on Mainland/Inter Island Shipping Services.

All other terms and conditions of the vacancy circular mentioned would remain the same.
